

## Bankwest Backyard Activation Experience Survey Competition

## **Terms and Conditions**

- 1. This competition commences at 12:00pm AWST on 1 March, 2024 and closes at 11:59pm AWST on 2 March, 2024 ('Promotional Period'). Taking part in this competition constitutes acceptance of these terms and conditions.
- 2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, ph. 13 17 19, is the promoter of this competition ('Promoter') authorised under the promotion governed by the laws of Western Australia and each entrant agrees to submit to the non-exclusive jurisdiction of Western Australia.
- 3. Entry is open to Australian residents ('Eligible Entrants') who:
  - a) Reside in Australia; and
  - b) are aged over 18.

- 6. There is a limit of one (1) entry per person.
- 7. The winner of the competition will be first (1) eligible entry drawn by random hand selection by a representative from Bankwest at Bankwest Place, Level 3B, 300 Murray St Perth WA 6000 on 5 March, 2024 at 2pm AWST ('Draw Date').
- 8. The winner will be notified via their advised contact email address or by phone within two (2) business days of the Draw Date.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and its related entities (including its respective directors, officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of:

  - b) Any theft, unauthorised access or third party interference;
