Identity Verification Form

Bankwest is required by the Anti-Money Laundering and Counter-Terrorism Financing Act 2006 to verify your identity. In addition we are required to verify your identity when you transact on an interest in land.

You can visit a participating post office in person to have your identity verified. The participating post office will verify your full name, date of birth and / or current residential address on behalf of Bankwest.

Your Identity Document (ID) Requirements

The information collected from you will be verified by the information contained in support of your application.

You must present an original of one of the below primary photographic identification documents:

Primary Photographic Identification

- Australian driver's licence or learner's permit (current)
- Australian passport (current or expired within the last 2 years)
- International passport (current and accompanied by a NAATI translation)
- Proof of age card (current and government issued)

How to lodge your application at Australia Post

- 1. Complete this form and bring it with your original identification documents to any participating post office. Please note that not all post offices are able to provide this service. To find the nearest participating post office, please call 13 13 18 or go to https://auspost.com.au/locate/bankwest-id-verification.
- 2. Do not complete section D, your signature must be witnessed by the Australia Post verifier.
- 3. Identification documents must be presented and be original.
