B. Primary Non-Photographic Identification

- Australian birth certificate / extract
- Australian citizenship certificate
- Current Centrelink Pension Card or Health Care Card that entitles the person in whose name the card is issued to financial benefits
- Foreign Birth Certificate (current and accompanied by a NAATI translation)

C. Secondary Identification Documents

- Utility bill or council rates notice (less than 3 months old) that contains the name of the individual, his or her residential address and records provision of services to that address or that person
- Taxation Notice (less than 12 months old) which contains the name of the individual and his or her residential address and records a debt payable to or by the individual

How to lodge your application at Australia Post

- 1. Complete this form and bring it with your original identification documents to any participating post office. Please note that not all post offices are able to provide this service. - 2. Do not complete section C, your signature must be witnessed by the Australia Post verifier.
- 3. Identification documents must be presented and be original.
