

# Identity Verification Form

---

Bankwest is required by the *Anti-Money Laundering and Counter-Terrorism Financing Act 2006 (Cth)* to verify your identity. You can visit a participating post office in person to have your identity verified. The participating post office will verify your full name, date of birth and / or current residential address on behalf of Bankwest.

## Your Identity Document (ID) Requirements

The information collected from you will be verified by the information contained in the documents you produce in support of your application. You must present documentation to fulfil the following criteria:

- A.** two original primary photographic identification documents; or
- B.** an original of a primary photographic identification document and an original primary non-photographic identification document; or
- C.** two original primary non-photographic identification documents.

## A. Primary Photographic Identification

- Australian driver's licence or learner's permit (current)
- Australian passport (current or expired within the last 2 years)
- International passport (current and accompanied by a NAATI translation)
- Proof of age card (current and government issued)

## B. Primary Non-Photographic Identification

- Australian birth certificate / extract
- Australian citizenship certificate
- Current Centrelink Pension Card or Health Care Card that entitles the person in whose name the card is issued to financial benefits
- Foreign Birth Certificate (current and accompanied by a NAATI translation)

## How to lodge your application at Australia Post

1. Complete this form and bring it with your original identification documents to any participating post office. Please note that not all post offices are able to provide this service. To find the nearest participating post office, please call 13 13 18 or go to <https://auspost.com.au/locate/bankwest-id-verification>.
  2. Do not complete section C, your signature must be witnessed by the Australia Post verifier.
  3. Identification documents must be presented and be original.

Without this information Australia Post will be unable to provide our service.

Your personal information will also be disclosed to Bankwest and other service providers Bankwest uses to provide identity verification services, including credit reporting bodies, Commonwealth and state government departments and other verification partners who match your information with the information held by the issuer or official record holder via third party systems.
