

## 'Bankwest Customer Feedback Survey' Monthly Prize Draw ("Promotion")

## Terms and Conditions of Entry

- 1. Information about how to enter and prize details form part of these Conditions of Entry. Entry into this Promotion is deemed to be an acceptance of these Conditions of Entry.
- Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL / Australian credit licence 234945, Bankwest Place, 300 Murray Street, Perth WA 6000, phone 13 17 19, is the promoter of this Promotion ("Promoter" or "Bankwest"), authorised under NSW Permit No. LTPM/18/03148, ACT Permit No. ACT TP 18/00941.
- 3. The Promotion will be open from 12:00AM Australian Western Standard Time ("WST") on 1st June 2018 and will continue until 11:59PM WST on 31<sup>st</sup> May 2019 ("**Promotion Period**").
- 4. Entry is open to Australian residents, 14 years of age and older, who are Bankwest customers other than directors, employees or contractors of the Promoter and other agencies, firms or companies associated with the Promotion or Promoter (including suppliers of prizes), and their immediate families ("Eligible Entrants").
- 5. To register for the Promotion, Eligible Entrants must, during the Promotion Period, complete the following steps:
  - a. Receive an invitation from the Promoter to participate in the Bankwest Customer Feedback Study by way of email invitation;
  - b. Click on the bespoke online survey link contained within the email and;
  - c. Complete the qualifying survey by answering the survey questions and submitting the completed survey.



6. For each Entry Survey completed, Eligible Entrants will receive one entry into the Promotion ("Eligible Entry"). Each Entry Survey may only be completed once.

## Monthly prizes

Computerised random draws for monthly prizes ("Monthly Draws") will take place at the times and dates set out in clause 9 at 300 Murray Street, Perth WA 6000 ("Draw Location"), from all entries received during the relevant Entry Period shown in clause 9. All Monthly Draws will be conducted by a representative of the Promoter.
- 8. The Eligible Entrants with the first two (2) valid Eligible Entries drawn in each Monthly Draw ("Winners") will win an electronic gift card supplied by GiftPay, each in the amount of \$200.00 including GST (each a "Monthly Prize"). Total Prize pool per month of \$400.00 including GST.

- d. Bankwest accepts no responsibility for loss or damage to Prizes in transit.
- 11. If any Prize remains unclaimed after 3 months of the draw, the Promoter will conduct an unclaimed prize draw in the same manner and place as the original draw, subject to any relevant regulations and directions from state authorities.
  - a. All winning entries from the original draw will be removed from the unclaimed prize draw.

If, for any reason, the Promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failure or any other causes beyond the control of the Promoter, which corrupt or affect the administration security, fairness or integrity or proper conduct of this Promotion, the Promoter reserves the



- right in its sole discretion to take any action that may be available, subject to State and Territory regulations.
- 19. Any entrant who, in the opinion of the Promoter, tampers or interferes with the entry mechanism in any way, or who does not properly comply with the entry process, will be ineligible to win.
- 20. Incomplete, illegible or incorrect entries or entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win.
- 21. The Promoter reserves the right to disqualify entries in the event of non-compliance with these terms and conditions of entry. In the event there is a dispute concerning the conduct of the Promotion, the decision of the Promoter is final and binding on each entrant and no correspondence will be entered into.
- 22. The Promoter reserves the right to request the Winners to produce appropriate photo identification or other documentation (to the Promoter's satisfaction) in order to confirm their identity, age, eligibility to enter and claim a Prize.
