

# Albany Wine & Food Festival Facebook Competition – Terms and Conditions

## How to enter

To be in the running to win one of two (2) VIP double pass to Albany Wine & Food Festival at Eyre Park, Middleton Road, Middleton Beach, Albany on the 6th of April 2019, simply post your favourite “foodie” emoji in the comments section below.

## Terms and Conditions

1. The Bankwest, Albany Wine & Food Competition (“Competition”) commences at 12:01am WST on 18th March 2019 and closes at 11:59pm WST on the 25th March 2019 (“Promotional Period”). Taking part in this Competition constitutes acceptance of these terms and conditions.
