

# Arctic Monkeys Instagram Competition Terms and Conditions

## How to enter

To be in the running to win one (1) double pass to the Arctic Monkeys concert at RAC Arena on the 23<sup>rd</sup> February 2019, simply - follow Bankwest on Instagram and name the artist depicted in the image via Instagram.

## Terms and Conditions

1. The Bankwest, Arctic Monkeys Instagram Competition ("Competition") commences at 12:01am WST on 15<sup>th</sup> of February 2019 and closes at 11:59pm WST on the 19<sup>th</sup> of February 2019 ("Promotional Period"). Taking part in this Competition constitutes acceptance of these terms and conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL / Australian credit license 234945, Bankwest Place, 300 Murray St, Perth WA 6000, phone 13 17 19 is the promoter of this Competition ("Bankwest").
3. To be eligible for entry ("Entrant") in the Competition you must ("Eligibility Criteria"):
  - a. Be aged over 18 or have parent(s) or guardian(s) permission to enter.
