

Bankwest Ideas Lab Monthly Prize Draw Competition

Terms and Conditions

1. This competition commences at 12:00am Australian Eastern Standard Time (“EST”) on Tuesday 1 June 2021 and closes at 11:59pm EST on Tuesday 31 May 2022 (**Promotional Period**). **Taking part in this competition constitutes acceptance of these terms and conditions.**
