

# The Bankwest Live at Perth Arena Ticket Giveaway Competition: Terms and Conditions

## How to enter:

Have your photo taken at the Bankwest stand via PIXTA on March 28 or March 29; and then share your image on Instagram using the #bankwest hashtag and follow the Bankwest Instagram account. Your profile must also be set to public.

## TERMS AND CONDITIONS

1. The Bankwest Live at Perth Arena Ticket Giveaway Competition ("Competition") commences at 5:00pm WST on Wednesday 28 March 2018 and closes at 11.59am WST on Friday 30 March 2018 ("Promotional Period"). Taking part in this Competition constitutes acceptance of these terms and conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 12 AFSL / Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, phone 13 17 19 is the promoter of this Competition ("Promoter" or "Bankwest").
3. To be eligible for entry ("Entrant") in the Competition you must ("Eligibility Criteria"):
  - a) Be aged over 18, or have parent(s) or guardian(s) permission to enter.
