

Terms & Conditions: The Bankwest Mumford and Sons Facebook Competition

How to enter:

To be in the running to win one (1) double pass to the Mumford and Sons concert at RAC Arena on the 27th January 2019, simply name the artist depicted in the image via Facebook.

Terms and conditions

1. The Bankwest, Mumford and Sons Facebook Competition ("Competition") commences at 10:00am WST on 14 January 2019 and closes at 11:59pm WST on 17 January 2019 ("Promotional Period"). Taking part in this Competition constitutes acceptance of these terms and conditions.
