

Terms and Conditions: Bankwest RAC Arena Shania Twain Concert Competition

Terms and Conditions

To be in the running to win one (1) double pass to Shania Twain at RAC Arena on 30 November 2018 simply comment on the nominated Facebook post telling us the name of the artist described in the post.

1. The Bankwest RAC Arena Shania Twain Concert Competition ("Competition") commences at 9:00am WST on 13 November 2018 and closes at 11:59pm WST on 18 November 2018 ("Promotional Period"). Taking part in this Competition constitutes acceptance of these terms and conditions.
