

Terms and Conditions: RAC Arena Competition

To enter:

Go in the running to win one (1) of two (2) prizes, consisting of either three (3) double passes to see the Perth Wildcats or three (3) double passes to see the Mastercard Hopman Cup at RAC Arena. To enter, comment on our nominated Instagram post to tell us if you'd prefer to attend the basketball or tennis event this summer.
