

Terms and Conditions: Bankwest Stadium Ticket Giveaway Facebook Competition

Terms and Conditions

1. This competition commences at 12:01 AEST and closes at 23:59 AEST in accordance with the promotional periods specified in Appendix 1 of these Terms and Conditions which correspond to each listed Event ('the Promotional Period'). Taking part in this competition constitutes acceptance of these Terms and Conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit license 234945, Bankwest Place, 300 Murray St, Perth WA 6000, phone 13 17 19 is the Promoter of this competition, authorised under NSW TPL number LTPS/19/38990.
3. Entry is open to Australian residents ('Eligible Entrants') who reside in NSW and:
 - a. Are aged 18 years of age and older; or
 - b. Are aged between 16 years of age and 17 years of age and have parent(s) or guardian(s) permission to enter.
4. To enter, Eligible Entrants must:
