

Terms and Conditions of Entry for the Bankwest Treejack Customer Research prize draw (“Promotion”)

1. Information about how to enter and prize details form part of these Conditions of Entry. Entry into this Promotion is deemed to be an acceptance of these Conditions of Entry.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit licence 234945 Bankwest Place, 300 Murray St, Perth WA 6000 is the promoter of this Promotion (“**Promoter**”).
3. The Promotion will be open from 12:00AM Australian Western Standard Time (“WST”) on 28th June 2016 and will continue until 11:59PM WST on 18th July 2016 (“**Promotion Period**”).
4. Entry is open to Australian residents, 18 years of age and older, who are Bankwest customers other than directors, employees or contractors of the Promoter and other agencies, firms or companies associated with the Promotion or Promoter (including suppliers of prizes), and their immediate families. To be eligible to claim the prize the entrant must be a member of the Ideas Lab panel on the date of the draw (“**Eligible Entrants**”).
5. To register for the Promotion, Eligible Entrants must, during the Promotion Period, complete the following steps:
 - a. Receive an invitation from the Promoter to participate in the Bankwest Treejack Customer Research (by way of an email)
 - b. Click the link in the email to start the online survey
 - c. Complete the qualifying survey available on the Website by accurately answering the survey questions and submitting the completed survey

PRIZES

The Draw will be conducted by a representative of the Promoter.
8. The five Eligible Entrants with the first five (5) valid Eligible Entries drawn in the Draw (“**Winners**”) will win a Coles Group & Myer Gift Card each in the amount of \$100.00, including GST (each a “**Prize**”).
