

The Bankwest Vegas Vacay Prize Promotion

Terms and Conditions

1. The Bankwest Vegas Vacay Prize Promotion ("Promotion") will commence at 00:01am WST on Monday 14 May 2018 and conclude at 11:59pm WST Sunday 24 June 2018 ("Promotional Period"). Taking part in this promotion (competition) constitutes acceptance of these terms and conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL / Australian credit Licence 234945, Bankwest Place, Murray St , Perth WA 6000, phone 13 17 19 is the promoter of this Promotion ("Bankwest") authorised under NSW LTPS/18/24120 and ACT TP 18/00841.
3. To be eligible for entry ("Entrant") into the Promotion you must ("Eligibility Criteria"):
 - a. Be a Bankwest customer;
 - b. Hold a Bankwest Debit Mastercard® and/or Bankwest Mastercard Credit Card ("Account") that is not in arrears. The Account must remain open until after the prize has been awarded;
 - c. Customer must not be flagged as under financial hardship/difficulties and potential hardship.
 - d. Be 18 years of age or over;
 - e. Be a resident of WA, NSW, VIC, QLD, TAS or ACT; and
 - f. Accept the Bankwest privacy policy (available at www.bankwest.com.au)
4. Employees and agents, and their immediate family, of the Commonwealth Bank Group (including Bankwest) and Mastercard and their associated agencies and entities are not eligible to enter the Promotion.
5. To enter this Promotion you must meet the following Entry Requirements ("Entry Requirements"):

- a. Satisfy the Eligibility Criteria;
 - b. Register for the Promotion by clicking on the 'Enter now' button in the email sent directly to the customer. Clicking on this button registers the customers' acceptance of this promotions terms & conditions;
 - c. Make a total of at least 5 (1 entry) eligible purchases, using their Bankwest Debit or Credit Mastercard during the promotional period;
 - d. Eligible purchases must be completely authorised on or before 11.59pm WST Sunday 24 June 2018 to be included;
 - e. If a customer's card is reported as lost or stolen during the promotional period, any disputed or fraudulent transactions on the card will not be eligible for entry in this promotion.
6. Eligible Purchases ("Eligible Purchases") excludes the following transaction types:
- a. Balance transfers;
 - b. Cash advances;
 - c. Fees and charges (including government fees and charges);
 - d. Interest charges;
 - e. Transactions which are disputed or fraudulent, payments and purchases which are refunded or reimbursed;
 - f. Purchases made for gaming or gambling transactions, or where items equivalent to cash are obtained, such as travellers cheques or foreign currency.
7. Participants are encouraged to use only one of their eligible cards to participate.
8. For every 5 eligible purchases a customer will be awarded 1 entry, there is no limit to the amount of entries. Eligible purchases are described in clause 6 of these terms and conditions. The total number of entries will be identified at the end of the promotion period. All entries will then be combined to be used for our random draw.

9. Entries are valid per email address. If you and another party have a joint account or are an additional cardholder and share an email address for your cards, only the primary card holder will be recognised as a valid entrant.

The first valid entry drawn will win the Major Prize ('Major Prize Winner'). After the Major Prize Winner has been determined, the next 20 valid entries drawn from the remaining entries will each win a Runner Up Prize ('Runner Up Prize Winners').

 - vii. US\$500 voucher for Bardot Brasserie at ARIA Resort & Casino.
 - viii. Private Pink Cadillac tour of Las Vegas with Elvis for two (2).
 - ix. Two (2) tickets on The High Roller at the LINQ.
 - x. \$1,000 Australian dollars spending money deposited into your Bankwest Account.

- xi. Total value of Prize is up to \$20,900. Note: all prize experiences are subject to availability at time of booking (see clause 23)
12. There are twenty (20) runner up prizes to be won ('Runner Up Prize/s'), with a total value of \$2,000.00. Each Runner Up Prize consists of:
 - A digital GiftPay voucher valued at \$100.00.
13. The total Prize pool value is up to \$22,900. Total cost may differ depending on winners selected travel dates and departure city.
14. Bankwest will inform the Winner that they have won the Promotion by phone and email on 10 July 2018. The Winner's details will be announced online at www.bankwest.com.au/terms-conditions/promotional-terms-conditions and in The Australian newspaper on or before 10 August 2018.
15. The spending money outlined in clause 10(v) will be deposited to the Major Prize Winners' Account within 12 business days of acceptance/acknowledgment. The Prize amount will only be deposited to the Bankwest Card used to enter the Promotion.
16. The Winner and their travelling companion must travel at the same time on the same flight, must depart from the same capital city and are each responsible for transport from and to their residence to their nearest capital city for flight departure/ flight return.
