

# Bankwest Work Perks Hugh Jackman Competition

## How to enter:

Entry to this competition is by registering your attendance to the – Demystifying Aged Care information session via the Bankwest Work Perks – Book Now link and attending at least one of the two sessions on the 13<sup>th</sup> of August 2019 held at 220 St Georges Terrace Perth.

## Terms and Conditions

1. The Bankwest Work Perks Hugh Jackman Competition (“Competition”) commences at 9.00am WST on 23rd of July 2019 and closes at 1.00pm WST on 13<sup>th</sup> of August 2019 (‘Promotional Period’). Taking part in this competition constitutes acceptance of these Terms and Conditions.
