

Best seats in the house Ticket Giveaway Competition

Terms and Conditions

- 1. This competition commences at 12:01pm AWST on 3 December 2024 and closes at 12:00pm AWST on 4 March 2025 ('Promotional Period'). Taking part in this competition constitutes acceptance of these terms and conditions.
- 2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, ph. 13 17 19, is the promoter of this competition ('Promoter') authorised under the promotion governed by the laws of Western Australia and each entrant agrees to submit to the non-exclusive jurisdiction of Western Australia.
- 3. Entry is open to Australian residents ('Eligible Entrants') who:
 - a) Reside in Western Australia; and
 - b) are aged over 18.

Three (3) x two (2) GA tickets to Human Nature at RAC Arena including a \$20 RAC Arena food and beverage voucher, on 5 April 2025. Prize is valued at \$749.70.

In addition, should other events be announced with tickets released to any event at RAC Arena, Optus Stadium or with the Fremantle Dockers Football Club that fall between the period of 4 March 2025 – 6 May 2025, additional draws will be made on the allocated draw dates mentioned at clause 9.
