

Terms and Conditions: Bankwest Customer Feedback Survey Monthly Prize Draw

Terms and Conditions

1. This competition commences at 12:00AM Australian Western Standard Time ("WST") on 1st June 2019 and closes at 11:59PM WST on 31st May 2020 ("Promotional Period"). Taking part in this competition constitutes acceptance of these terms and conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit licence 234945, Bankwest Place, 300 Murray Street, Perth WA 6000, ph. 13 17 19, is the promoter of this competition, authorised under NSW Permit LTPM/19/04440, ACT Permit ACT TP 19/03333 and SA Permit T19/763.
