

Terms and Conditions: Disney on Ice Facebook Competition

To enter

To be in the running to win one (1) of eight (8) double passes to Disney on Ice concert at RAC Arena on 2 & 3 June 2019 simply comment on the nominated Facebook post telling us the name of the event depicted.

Terms and Conditions

1. The Bankwest Disney on Ice Facebook Competition ("Competition") commences at 9am WST on 30 April 2019 and closes at 10am WST on 9 May 2019 ("Promotional Period"). Taking part in this Competition constitutes acceptance of these terms and conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 12 AFSL / Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, phone 13 17 19 is the promoter of this Competition ("Promoter" or "Bankwest").
3. To be eligible for entry ("Entrant") in the Competition you must ("Eligibility Criteria"):
 - a. Be aged over 18, or have parent(s) or guardian(s) permission to enter.
 - b. Be a resident of Western Australia.
4. To enter, Entrants must comment on the nominated Facebook post on Bankwest Facebook page with their answer to the name of the event depicted in the image during the Promotional Period ("Entry Requirements").

Each Winner consents, or the Winner'(s) parent(s) or guardian(s) consent, to the Promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in media for an unlimited period of time without remuneration for the purpose of promoting this Competition (including any outcome), the Promoter and or products/services supplied by the Promoter.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and its related entities (including its respective directors, officers, employees and agents) and Facebook, are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of:
 - a. any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
 - b. any theft, unauthorised access or third party interference;
 - c. any entry or Prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
 - d. any variation in Prize value to that stated in these terms;
 - e. any tax liability incurred by a beneficiary of a Prize (including an Entrant and the Prize Recipient);
