

Domain Test Australia v India Facebook Competition – Terms and Conditions

How to enter

Terms and Conditions

1. The Bankwest Domain Test Australia v India Facebook Competition (“Competition”) commences at 10:00am WST on 6 December 2018 and closes at 12:00pm WST on 11 December 2018 (“Promotional Period”). Taking part in this Competition constitutes acceptance of these terms and conditions.
