

Bankwest Easy Transaction Account cashback promotion

Promotion Terms and Conditions

1. The Promotion commences at 12.01am 1 April 2017 and closes at 11:59pm WST on 30 June 2017 ('Promotional Period').
2. The 'Promoter' is Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit license 234945, Bankwest Place, 300 Murray St, Perth WA 6000 ('Bankwest').
3. The Promotion is open to individuals ('Eligible Customer') who satisfy the following eligibility criteria ('Eligibility Criteria'), individuals must:
 - a. Open a Bankwest Easy Transaction Account during the Promotional Period;
 - b. Make a minimum of 5 tap & go™ purchases ('Eligible Purchases') using their Debit Mastercard or Android Pay™ linked to the Eligible Account;
 - c. be an Australian resident;
 - d. be 18 years of age or over;
 - e. Not have held a Bankwest transaction account in the previous 6 months. Customers who currently hold or who have previously held any other Bankwest transaction account product in the preceding 6 month period are ineligible for this offer;
4. Provided that they meet the Eligibility Criteria, Eligible Customers will receive a cashback equal to 2% of their Eligible Purchases, to a maximum of \$50, to their Bankwest Easy Transaction Account each month until 31 August 2017. The cashback is payable monthly from account open date to 31 August 2017 and will be credited to the eligible account within 60 days of the end of each month.
5. The following purchase types are excluded and are not considered eligible purchases ('Eligible Purchases'): gaming or gambling transactions including gambling chip purchases and online gambling purchases, purchases that are subsequently refunded to the account and fraudulent transactions.
6. Directors and employees of the Promoter are not eligible for the Promotion.
7. Eligible Customers accept the cashback 'as is' and acknowledge that the Promoter accepts no responsibility for any tax implications that may arise from the bonus. Customers should seek advice from the Australian Tax Office or their own tax advisor or independent financial advisor.
