

Terms and Conditions: Facebook Cat Naming Competition

How to enter

To be in the running to win \$1000, simply comment on the nominated Bankwest Facebook post with your suggested name for Bernie's cat.

Terms and Conditions

1. This competition commences at 12:01am WST on Friday 19 June 2020 and closes at 11:59pm WST on Monday 6 July 2020 ("Promotional Period"). Taking part in this competition constitutes acceptance of these terms and conditions.

Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 12 AFSL / Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, phone 13 17 19 is the promoter of this Promotion ("Bankwest"). The promotion is governed by the laws of Western Australia and each entrant agrees to submit to the non-exclusive jurisdiction of Western Australia.
