

Terms and Conditions: Fleetwood Mac Facebook Competition

To enter:

To be in the running to win one (1) of three (3) double passes to Fleetwood Mac concert at RAC Arena on 9 & 11 August 2019 simply comment on the nominated Facebook post finishing the lyric depicted.

Terms and Conditions

1. The Bankwest Fleetwood Mac Facebook Competition ("Competition") commences at 9am WST on 29 July 2019 and closes at 11:59pm WST on 4 August 2019 ("Promotional Period"). Taking part in this Competition constitutes acceptance of these terms and conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 12 AFSL / Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, phone 13 17 19 is the promoter of this Competition ("Promoter" or "Bankwest"). The promotion governed by the laws of Western Australia and each entrant agrees to submit to the non-exclusive jurisdiction of Western Australia.
