

Fly with the Team Ticket Giveaway Competition

Terms and Conditions

- 1. This competition commences at 12:00pm AWST on 14 April, 2024 and closes at 12:00pm AWST on 28 May, 2024 ('Promotional Period'). Taking part in this competition constitutes acceptance of these terms and conditions.
- 2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, ph. 13 17 19, is the promoter of this competition ('Promoter') authorised under the promotion governed by the laws of Western Australia and each entrant agrees to submit to the non-exclusive jurisdiction of Western Australia.
- 3. Entry is open to Australian residents ('Eligible Entrants') who:
 - a) Reside in Australia; and
 - b) are existing Bankwest customers; and
 - c) are aged over 18.

- 6. There is a limit of one (1) entry per person.
- 7. The winner of the competition will be first (1) eligible entry drawn by random hand selection by a representative from Bankwest at Bankwest Place, Level 6C, 300 Murray St Perth WA 6000 on 29 May, 2024 at 2pm AWST ('Draw Date').
- 8. The winner will be notified via their advised contact email address or by phone within two (2) business days of the Draw Date.
- 9. The prize consists of
 - a) Two tickets into the Tom Wills Room to Round 21 AFL match (Essendon v Fremantle) (date to be confirmed upon release of AFL fixturing). Tickets include premium Level 2 reserved seating, three course meal, premium beverage package and reserved table throughout the match and valued at \$450.00 each.
 - b) Two return flights* from Perth to Melbourne with Virgin Australia on the Fremantle Football Club Charter Flight or, if unavailable, on a commercial flight to be determined at the Promoter's discretion. Flights are valued at up to \$850.00 per person.
