

Terms and Conditions: Optus Stadium Ticket Giveaway Facebook Competition

Conditions of Entry

1. This competition commences at 12:01am EST on the commencement date aligned with the competition detailed below and closes at 11:59pm EST of the date in [Appendix 1](#) ('Promotional Period'). Taking part in this competition constitutes acceptance of these terms and conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, phone 13 17 19 is the promoter of this competition.
3. Entry is open to Australian residents ('Eligible Entrants') who:
 - a. Reside in WA; and
 - b. Are aged 18 years of age and older; or
 - c. Are aged 16 to under 18 and have a parent(s) or guardian(s) permission to enter.
