

# Terms and Conditions: Perth Wildcats Facebook Competition

## To enter

To be in the running to win one (1) of four (4) prizes to see the Perth Wildcats vs Illawarra Hawks at RAC Arena on 11 October 2019, in a catered suite for you and three (3) friends, simply comment on the nominated Facebook post and name your favourite Perth basketball player.

## Terms and Conditions

1. The Bankwest Perth Wildcats Facebook Competition ("Competition") commences at 9am WST on 27 September 2019 and closes at 11:59pm WST on 6 October 2019 ("Promotional Period"). Taking part in this Competition constitutes acceptance of these terms and conditions.
2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL / Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, phone 13 17 19, is the promoter of this Competition ("Promoter" or "Bankwest"). The promotion is governed by the laws of Western Australia and each entrant agrees to submit to the non-exclusive jurisdiction of Western Australia.
3. Entry is open to Australian residents ("Eligible Criteria") who:
