

RAC Arena West Coast Fever round 8 Corporate Suite Giveaway Competition

Terms and Conditions

1. This competition commences at 10:00am Australian Western Standard Time (“WST”) on 14 June 2021 and closes at 12:00pm WST on 21 June 2021 (‘Promotional Period’). Taking part in this competition constitutes acceptance of these terms and conditions.
