

'Freo Wins, You Score' Easy Transaction Account Promotion

Terms and Conditions

1. The **'Freo Wins, You Score'** promotional offer ("Offer") is available to Fremantle Dockers fans who **open a new Bankwest Easy Transaction Account** ("Eligible Account") 'online' via www.bankwest.com.au/freodockers between **3 March 2026 and 31 March 2026** (by 6:00pm AWST), subject to meeting all eligibility criteria below.
2. **Eligibility Criteria**
 - a. **Customer Eligibility**
 - i. You must be a new Bankwest customer aged 18 years or older.
 - ii. You must not have held any Bankwest Account (in your own name or jointly) in the 12 months prior to opening the Eligible Account.
 - iii. For joint accounts, all account holders must meet these conditions.
 - b. **Monthly Spend Requirement**
 - i. You must make five (5) 'settled' 'eligible purchases' (fully processed and not pending) totalling at least \$20 in each calendar month from March to August 2026.
 - ii. There are six (6) monthly opportunities (from March 2026 to August 2026) to qualify for a cashback payment. If the spend requirement is not met in a month, you are eligible to participate in any subsequent months, providing all other 'Eligibility Criteria' is met in those months. *For example, if you do not meet the spend requirement in April, you*



will be eligible to participate in May, June, July and August by completing 5 eligible purchases totalling at least \$20 in each of those months.

3. Cashback Payment

- a. In each of the calendar months that the Eligibility Criteria is met, you will earn \$5 for every Fremantle Dockers win (that month) in the 2026 AFL Premiership Season, with payment made in arrears within 60 days following the end of that month. *For example, if the Dockers win 3 games in April, eligible customers will be paid \$15 within the 60 days from 30 April.*
- b. Cashback excludes games resulting in a draw and finals games.
- c. The cashback payment (if any) will be credited to your Easy Transaction Account within 60 days from the end of the completed month, provided your account remains open and in good standing at the time of payment.
- d. You will not be eligible for a cashback payment if your account is closed, reopened, switched to another Bankwest account, or is not in 'good standing' prior to the cashback being credited.

4. Competition Draw

- a. For every month the Eligibility Criteria is met, you will receive one (1) entry into the draw to win one (1) of two (2) 2026 Fremantle Dockers Team Signed Guernsey's. Competition [T&Cs apply](#). This competition draw is not open to residents of the Australian Capital Territory (ACT).

5. Promotion Limits

- a. Limit of one Offer per customer, up to a maximum of \$115 cashback (equivalent to 23 games).
- b. Only one Easy Transaction Account per customer is eligible during the promotional period.
- c. The \$115 cashback maximum applies to jointly held accounts.



- d. Participating in this Offer excludes you from participating in any other promotions or offers while this Offer is still valid.

6. General Conditions

- a. Bankwest reserves the right to amend or withdraw the promotion at any time.
- b. You must be opted into marketing to receive communications related to this Offer.
- c. There may be tax implications arising from this offer, particularly if the cashback or prize is received as an incident of your business or income-producing activities. If you're not sure about the tax implications, you should consider seeking advice from the Australian Tax Office or speak to your accountant or tax adviser.

7. Definitions

In these promotional Terms and Conditions, unless the context otherwise requires:

- a. **Bankwest Account** refers to any Bankwest transaction, savings, term deposit, home loan or credit card accounts issued by Bankwest, or other off-sale accounts.
- b. **Eligible purchases** are defined as purchases made with your linked Bankwest Platinum Debit Mastercard or Virtual Debit Card(s) but exclude cash withdrawals; cash-out transactions at any merchant; payments and transfers from the Account (for example, BPAY, Internal Transfers, Pay Anybody and Faster Payments); direct debits; gaming, lottery or gambling transactions; purchases / transactions that are subsequently refunded to the account; and fraudulent transactions.
- c. **Good standing** refers to accounts that have been operated in a manner we reasonably consider is consistent with the Terms and Conditions for the Bankwest Easy Transaction Account. For example, accounts that are not overdrawn or have no restrictions in place.



- d. **Online** refers to accounts applied for (and opened) through the promotional campaign landing page www.bankwest.com.au/freodockers using the 'Open an Easy Transaction Account' button. Excludes accounts applied for and opened directly through the Bankwest App.
- e. **Settled purchases** are defined as transactions that have been finalised by the merchant and posted to your statement. 'Authorisation Only' transactions are not fully processed and are considered as pending transactions. The date the transaction settles may differ from the day the purchase/transaction was performed.

8. Frequently Asked Questions

a. *How do I qualify for the monthly cashback payment?*

To qualify for a monthly cashback payment, you will need to:

- i. Via the promotional campaign landing page www.bankwest.com.au/freodockers, open new a Bankwest Easy Transaction Account between 3 March 2026 and 31 March 2026 by 6:00pm AWST;
- ii. be over the age of 18 years old and not have held any 'Bankwest Account' (either in your own name or jointly) in the previous 12-month period from the date of opening the Eligible Account. In the case of joint accounts, all account owners must meet this condition to be considered eligible for the promotion; and
- iii. make 5 'settled' (fully processed and not pending) 'eligible purchases' with a total minimum spend amount of \$20, within each calendar months of March, April, May, June, July and August 2026.

b. *If I make 5 eligible purchases in a calendar month, but the total dollar spend of those transactions is lower than \$20, will I still be eligible to earn the cashback payment?*



- i. No, to earn the cashback payment, you need to make 5 'settled' (fully processed and not pending) 'eligible purchases' with a total minimum spend amount of \$20 within the calendar month. These eligible purchases can be made with your linked Platinum Debit Mastercard or Virtual Debit Card.

c. Do I need to make 5 eligible purchases AND meet the minimum \$20 combined dollar spend of those transactions each month, to be eligible to earn the cashback payment?

- i. Yes, to earn a cashback payment, you will need to make 5 'settled' (fully processed and not pending) 'eligible purchases' with a total minimum spend amount of \$20 within a calendar month period. These eligible purchases can be made with your linked Platinum Debit Mastercard or Virtual Debit Card.

d. What if the Fremantle Dockers do not win any games in a month?

- i. In a calendar month where the Dockers do not win any games, you will not receive a cashback payment. However, if you have met the Eligibility Criteria for the month (i.e. have met the Monthly Spend Requirement) you will earn one entry into the draw to win signed Dockers memorabilia.

e. How do I know how much cashback I will earn each month?

- i. When you are eligible to earn a cashback payment, the value of the cashback is determined by how many games the Dockers win that month. Each game won is worth \$5. For example, if the Dockers won 3 games in April and you met the Eligibility Criteria in April, you will be paid \$15 cashback within the next 60 days.

f. When will my cashback be paid?

- i. If you have qualified to receive a cashback payment, it will be paid to your account within 60 days from the end of the qualifying month, i.e. For April, make your 5 eligible purchases (totalling \$20 in spend) by 30



April 2026, and the cashback payment (if any) will be paid by 29 June 2026.

g. How do I make purchases when I haven't received my physical card yet?

- i. While you wait for your physical card to arrive, you can use your digital card to make purchases online, or add your digital card to your digital wallet and start spending straight away with Apple, Google or Samsung Pay.
