

Bankwest Ultimate Football Ticket Giveaway Competition

Terms and Conditions

- This competition commences at 12:01pm AWST on 6 May 2025 and closes at 12:00pm AWST on 30 May 2025 ('Promotional Period'). Taking part in this competition constitutes acceptance of these terms and conditions.
- 2. Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, ph. 13 17 19, is the promoter of this competition ('Promoter') authorised under the promotion governed by the laws of Western Australia and each entrant agrees to submit to the non-exclusive jurisdiction of Western Australia.
- 3. Entry is open to Australian residents ('Eligible Entrants') who:
 - a. Reside in Western Australia; and
 - b. are aged over 18.
- 4. Eligible Entrants declare that they enter the Promotion in a wholly personal, private or domestic capacity and not in relation to any enterprise e.g. business undertaking.

- One (1) x two (2) Bankwest Club tickets to the AFL Round 15: Fremantle v Essendon at Optus Stadium, including food and beverage, on 19 June 2025. Prize is valued at \$500.
- One (1) x two (2) Bankwest Club tickets to the AFL Round 16: Fremantle v St Kilda at Optus Stadium, including food and beverage, on Date TBC. Prize is valued at \$500.
- One (1) x two (2) Bankwest Club tickets to the British & Irish Lions Tour at Optus Stadium, including food and beverage, on 28 June 2025. Prize is valued at \$500.

In addition, should other events be announced with tickets released to football events at Optus Stadium or with the Fremantle Dockers Football Club that fall between the period of 1 June 2025 - 30 June 2025 additional draws will be made on the allocated draw dates mentioned at clause 9.

- 12. Prize(s) is/are not transferable or redeemable for cash. The total prize pool value is up to \$5,060. Prize valuation is accurate as of 24 April 2025. Subject to change. This amount does not include the value of tickets to events at RAC Arena, Optus Stadium or with the Fremantle Dockers Football Club during the promotional period that have not been announced yet.
