

Easy Transaction Account Targeted Cashback Offer

Terms and Conditions

- This cashback promotional offer is only available to select Bankwest Easy Transaction
 Account customers and is not available to all customers.
- 2. Eligible customers who received the offer will be provided a cashback of \$50 where the below conditions are met. A customer must meet offer conditions for all three consecutive months of October, November and December 2025 to be eligible to receive the cashback. To be eligible, a customer must:
 - a. Make a minimum of 10 'settled' (fully processed and not pending) 'eligible purchases' with a total minimum spend amount of \$50 per month, culminating in a total minimum of 30 eligible purchases from 1 October 2025 31 December 2025:
 - i. 10 or more settled eligible purchases with a total minimum spend of \$50 between 1
 October 2025 31 October 2025 using the Easy Transaction Account; AND
 - ii. 10 or more settled eligible purchases with a total minimum spend of \$50 between 1
 November 2025 30 November 2025 using the Easy Transaction Account; AND
 - iii. 10 or more settled eligible purchases with a total minimum spend of \$50 between 1 December 2025 – 31 December 2025 using the Easy Transaction Account.
- 3. Only Settled Purchases are Eligible Purchases.
- 4. The cashback payment will be credited to the Easy Transaction Account within 45 days from the end of the qualifying period, providing the Bankwest Easy Transaction Account is still open at the time of crediting.



- 5. You will be ineligible for any cashback payment if your account is closed, reopened, switched to another Bankwest Transaction or Savings Account or the account is considered not to be in 'good standing' at any time prior to the cashback being credited to your account.
- 6. Limit of one promotion, up to a maximum \$50 cashback. Only available on the Easy

 Transaction Account targeted in the promotional offer. \$50 cashback maximum applies to
 jointly held accounts.
- 7. Acting reasonably, Bankwest may amend or withdraw the promotion at any time.

Definitions

In these promotional Terms and Conditions, unless the context otherwise requires:

Eligible Purchases are Settled Purchases made with your linked Bankwest Platinum Debit Mastercard or Virtual Debit Card(s) but exclude cash withdrawals; cash-out transactions at any merchant; payments and transfers from the Account (for example, BPAY, Internal Transfers, Pay Anybody and Faster Payments); direct debits; gaming, lottery or gambling transactions; purchases / transactions that are subsequently refunded to the account; and fraudulent transactions.

Good Standing refers to accounts that have been operated in a manner we reasonably consider is consistent with the Terms and Conditions for the Bankwest Easy Transaction Account. For example, accounts that are not overdrawn or have no restrictions in place.

Settled Purchases are transactions that have been finalised by the merchant and posted to your statement as at 31 December 2025. 'Authorisation Only' transactions are not settled or fully processed and are considered as pending transactions. The date the transaction settles or is fully processed may differ from the day the purchase/transaction was performed.
