

2025 Fremantle Dockers Team Signed Guernsey Giveaway Competition

Terms and Conditions

- This competition commences at 10:00am AWST on 1 September 2025 and closes at 10:00pm AWST on 4 September 2025 ('Promotional Period'). Taking part in this competition constitutes acceptance of these terms and conditions.
