



Identity Verification Form

Bankwest is required by the Anti-Money Laundering and Counter-Terrorism Financing Act 2006 to verify your identity. You can visit a participating post office in person to have your identity verified. The participating post office will verify your full name, date of birth and / or current residential address on behalf of Bankwest.

Your Identity Document (ID) Requirements

The information collected from you will be verified by the information contained in the documents you produce in support of your application. You must present documentation to fulfil the following criteria:

- A.** an original of a primary photographic ID document; or
- B.** two original primary non-photographic identification documents; or
- C.** an original of a primary non-photographic identification document and an original of a secondary identification document.

A. Primary Photographic Identification

- Australian driver's licence or learner's permit (current)
- Australian passport (current or expired within the last 2 years)
- International passport (current and accompanied by a NAATI translation)
- Proof of age card (current and government issued)

B. Primary Non-Photographic Identification

- Australian birth certificate / extract
- Australian citizenship certificate
- Current Centrelink Pension Card or Health Care Card that entitles the person in whose name the card is issued to financial benefits
- Foreign Birth Certificate (current and accompanied by a NAATI translation)

C. Secondary Identification Documents

- Utility bill or council rates notice (less than 3 months old) that contains the name of the individual, his or her residential address and records provision of services to that address or that person
- Taxation Notice (less than 12 months old) which contains the name of the individual and his or her residential address and records a debt payable to or by the individual
- School Aged Children under 18 - a notice issued by a School Principal within the last 3 months with the name, residential address of the person and the period of time the person attended the school (the document must be one page only)

How to lodge your application at Australia Post

1. Complete this form and bring it with your original identification documents to any participating post office. Please note that not all post offices are able to provide this service. To find the nearest participating post office, please call 13 13 18 or go to <https://auspost.com.au/locate/bankwest-id-verification>.
 2. Do not complete section D, your signature must be witnessed by the Australia Post verifier.
 3. Identification documents must be presented and be original.
